#### Lasting power of Attorney - Health and Welfare

When we have our health we don't like to think about what may happen in the future, but illness or accidents can intervene without warning. Advances in science mean we are living longer but sadly, this increases our chances of ending our days without our mental faculties.

Many people understand you can appoint attorneys to help with your finances and property with a Lasting Power of Attorney (LPA) and an existing Enduring Power of Attorney will also do this. However more people are now also making an LPA which deals with health and personal welfare. Confusingly this is a quite separate document from the more usual form of LPA and is not covered at all by the old EPA.

Health and Welfare attorneys are able to make decisions on your behalf about where you live and who you live with; your dailycare; who you have contact with; consenting to or refusing medical treatment; you can even specify that your attorneys make end of life decisions for you if you wish.

# "So what happens if you don't have an LPA in place?"


In practice these important health and welfare decisions are left to professionals - doctors, social workers or care staff. Any professional should consult with you (to the extent that you still have some mental understanding) and your carers, and take reasonable steps to reach agreement. They may also consult with family members, but do not have to. However consultation does not necessarily mean that they have to follow the carers' or the family's wishes, and professionals are busy people who will not know you as well as those close to you.

Doing a Health and Welfare LPA means you decide who makes these decisions for you if you can't make them yourself and ensures

your relative or carer has more say on your health and welfare matters. They make decisions based on your best interests and their knowledge of what you would have wished, and there is also the ability for you to enable them to make decisions whether you should receive life sustaining treatment.

Of course you have to completely trust your attorneys will make the right decisions for you, but if you are fortunate with your relatives and carers the Health and Welfare LPA is most probably the right thing to do.

It has been designed by Martin Jennings who is famous for the John Betjeman statue at St Pancras.

during the wars, but not so much about what the women were doing. Without the women of Sheffield, there would not have been tanks and fighter planes; and these brave women continued with their vital work throughout bombing raids doing long and exhausting shifts to keep the steel works running.

Unfortunately so many of the Women of Steel have passed

away in the last few years. But we are sure that amongst our clients there will be some who made this vital contribution to the war; and many others who remember their mothers and grandmothers as Women of Steel.

We are hoping that as many of our clients as possible will enter the Star Walk to raise money towards this fund. It is only a one mile walk as some of the surviving Women of Steel now in their 80s and 90s are planning to do this. We hope you will join them. #### Lasting Power of Attorney - Finances and Affairs.

We persuaded, indeed cajoled, many of the clients who came to do wills with us before 2007 to also make an Enduring Powers of Attorney. They were comparatively simple to set up and provided a good safety net against the possibility that one day in the future it may be necessary for family or friends to take over managing your property and affairs.

Since 2007 it has not been possible to change existing Enduring Powers of Attorney or make new ones. But those which were in place prior to then are still valid.

We are finding that some of our clients with existing EPAs are now coming to us wanting to do an LPA in its place. Why?

Sometimes it is just because of change of circumstances. You wish to change one or more of your attorneys; and you can put in substitute attorneys if the preferred ones can no longer act.

Most importantly, an LPA is more flexible. If an EPA is registered it means that your attorneys have to take over all the property and finances - and for someone still living independently, albeit with mental faculties becoming more frail, it means the inability to even write small cheques. This means that many people delay registration, and

it can end up with an elderly person being more at risk. With an LPA for Property and Finance you can leave the attorneys to manage the big things but still leave you to be in charge of your current account and make sure that you can pay the window cleaner and pay for your groceries.
